- 1. The Kingdom of Cambodia has received a Credit from the World Bank toward the cost of General Education Improvement Project, Ministry of Education, Youth and Sport and it intends to apply part of the proceeds of this Credit to payments under the Contract for supply, delivery and installation of Furniture for school buildings and Teacher House Phase II, Ref: MoEYS-GEIP-NCB-G-007.
- 2. The General Education Improvement Project, Ministry of Education, Youth and Sport now invites sealed bids from eligible and qualified bidders for supply, delivery and installation of Furniture for school buildings and teacher house Phase II, Ref: MoEYS-GEIP-NCB-G-007.
  - The Bidder evaluation and qualification criteria are included in Section II of the bidding document. Bid evaluation and contract award will be on package-wise basis.
- 3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of the World Bank.
- 4. This invitation is open to all bidders.
- 5. Interested eligible bidders may obtain further information and inspect the Bidding Documents at the link given below from **18 February 2025 to 19 March 2025** from 08:00-12:00 and 13:30- 17:30 hours (Cambodia Standard Time).
- 6. For the package, qualification requirements specified in ITB Sub-Clause 14.2 of the bidding documents include:
  - The bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years with the value each contract not less than 50% of the subject bid price.
  - The bidder has completed contracts in the total cumulative amount equal to at least two times of the subject bid price in the preceding two years.
  - The manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 5 years in the manufacturing of similar goods.

- The bidder has availability of liquid assets through either: (a) access to a line of credit or cash in bank account of an amount at least 50% of the subject bid price, net of other contractual commitments; or (b) credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
- Bidders must submit audited financial statements for the last three (3) years (2022, 2023 & 2024) to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last three (3) years calculated as the difference between total assets and total liabilities should be positive. It should be clearly shown that the financial statements of the firm/s have been prepared by the firm/s while those statements have been audited by an independent entity, and should not violate the relevant national statutory accounting standard. Without compliance with this requirement, the Bidder shall be considered non-responsive. The documentary evidence must be submitted with the bid. The reports on the financial standing of the Bidder, such as profit and loss statements, certified financial statements from licensed certified accountant or auditor's report.
- 7. A complete set of Bidding Documents (Soft Copy) may be obtained free-of-charge by requesting through filling the Google Form stated in IFB para 12. Except for the submission of a written application through email, there shall be no other conditions for obtaining the bidding documents.
